# SB43 County Funded Inpatient Hospitalization Authorization Requests



### SB43 Inpatient (IP) Psychiatric BHU Requests

1. Hospital ruled out co-occurring Mental Health (MH) & confirmed:

Standalone severe SUD + GD + Legal Hold

1a. If co-occurring, STOP SB43 workflow and request MH authorization per usual "San Diego IP Concurrent Review Authorization Process"

2. Call Optum (800-798-2254, option 3 then 1) and **fax** request (866-220-4495) using Inpatient Auth Request Fax Cover Sheet **marked** "**SB43/IP BHU**" with required documents (include plan for SUD recovery services)

3. If during admission or at **first** continuation request, it's identified the client is cooccurring, hospital may instead request authorization per usual MH pathways (MH authorization to begin date of admission)

4. Optum makes SB43/IP BHU admission determination within 24 hours and continuation determination within 1 business day

#### 5. Admission requests-up to 3 acute IP BHU days authorized

#### 6. Continuation requests

6a. Before submitting continuation, hospital calls API to check Chemical Dependency Recovery Hospitalization (CDRH) bed availability; if available coordinate transfer\*
6b. If CDRH bed not available, continuation may be submitted before end of previous authorization & up to 4 acute days authorized
6c. Administrative days may be authorized on a case-by-case basis

7. If modified/denied: hospital may request expedited/informal appeal review

8. Upon discharge, hospital faxes to Optum IP Auth Request Fax Cover Sheet **marked SB43/IP BHU** with required documents

9. UB04 facility claim submitted to Optum; retroactive requests mark SB43 IP/BHU
